The Committee examined various affiliation cases and accorded approvals in deserving cases. A copy of the statement, duly signed, containing the names of ITIs /ITCs/Trades/Units, in respect of your State which have been approved/rejected, along with remarks if any is enclosed. The said information is also available for reference on internet <http://dget.gov.in> however hard copy duly signed would be treated as authenticated. On the basis of this, affiliation orders may be issued to the Management of the concerned ITIs/ITCs which have been approved, whereas to the other Institutes, orders are to be issued for the conditions/actions (as stated in the remarks column) for compliance.

Your kind attention is also drawn that a decision has already been taken in the Sub-Committee of NCVT held on 24/8/2007 stating that Sub-Committee of the NCVT dealing with affiliation of henceforth should not keep cases with "Under consideration" (UC) on account of minor deficiencies. It is once again emphasized that NCVT courses should be started only after getting approval from Sub-committee of NCVT.

In respect of Multiskilling courses under the scheme Center of Excellence (CoE) being offered at ITI however for time being clause of Under consideration cases will be continued keeping in view the adjustments of trades. You are therefore requested to make up all the deficiencies pointed out in the remarks column and send the reports immediately for taking further action for affiliation.

It is further informed that the utmost care may please be taken of the following points while forwarding affiliation proposed for CoE Scheme:

1. Affiliation Reports consisting of minimum 3 Modules under (BBBT) scheme of respective Sector to be forwarded to DGET (HQ.)
2. Affiliation order under (BBBT) scheme will only be issued when all the 6 modules pertaining to the respective Sector are affiliated with NCVT.

3. U.C case will be withdrawn if SIR/DIR/SCIR is not forwarded within 5 months.

It may please be noted, that the cases which have been rejected, require fresh standing committee inspection/departmental inspection as the case may be, for grant of affiliation of trades/ units accordingly the institutes may please be advised. The State Director(s) are requested to enclose copy(s) of proof of availability of Power Supply alongwith copy(s) of Electricity consumption bill of ITI/ITCs and other documents as mentioned in the Training Manual of CTS with every affiliation report to enable us to process the same at DGE&T (HQs), New Delhi. In case of any document in regional language duly authenticated extract translated in English may please be enclosed.

It has been decided in the Sub-Committee meeting held on 23/11/2007 that those affiliation case which are more than 2 years should not be forwarded to DGET for affiliation except in case of official lapses so that careers of the students may not hampered.
